Name of Project: Sierra Mountain Center, LLC

Description of Project: Guiding rock climbing activities on Dome rock and the Needles complex using established climbing routes between May 15 and October 31, 2016, not to exceed 200 service days. Overnight camping will occur in developed campgrounds and accessing climbing areas will be on the established trails. All activities will be supervised by a licensed guide. Holder, employees, contractors and representatives shall be familiar with the terms and conditions of the Special Use Authorization and carry a copy of the operating and maintenance plan while operating. Prudent Measures for the Peregrine falcon and nesting cycle are described in the special use permit. (Sec 13,14,28, &33, T21S, R32E) on the Western Divide Ranger District, Sequoia National Forest. (Map attached).

Groups will be using established trails and no ground disturbance is planned.
